Horsemen across the country benefit from this program as it provides more opportunities to race, increased purses, and the ability to find competitive racing for horses of every level. Over \$5 million in Challenge money is awarded in purses and enrollment awards each year.

We invite you to be part of the 2016 Bank of America Racing Challenge. There are several ways to get involved, so we encourage you to review the applications and select the best option for your track and horsemen.

The Racing Challenge comprises regional qualifying races in five divisions; the winners of each qualifier compete in the fall for over \$1 million in purse money in the Bank of America Challenge Championships, which will be held at Los Alamitos in 2016.

The Bonus Challenge series offers horsemen additional opportunities to run their Challenge-enrolled horses for added money from the Challenge program. New in 2015, invitations are now extended to the ten winners of Bonus Challenge races with the highest current year earnings to compete in the Invitational Bonus Challenge Championship during the Challenge Championships.

Finally, the Maiden Challenge program gives horsemen a chance to run their Challenge-enrolled three-year-old and up maidens for added money from the Challenge program.

If you are interested in hosting a Regional, Bonus, and/or Maiden Challenge event, please complete and return the corresponding application by January 8th, 2016. If you have any questions about the application process or the program in general, please contact us.

Please note that there are changes to the regional and Challenge Championship races regarding drug testing rules for 2016. Complete rules are currently pending and will be available in the 2016 Racing Challenge Condition Book, which will be available soon. In the meantime, contact the AQHA Racing Department with questions.

- Winners of Bonus Challenge races do not receive automatic berths to Challenge Championship races; however, ten winners of Bonus Challenge races will be invited to compete in the Invitational Bonus Challenge Championships based on year-to-date Challenge-money earned.
- We encourage you to include "Bonus" in the race title to help communicate and attract horsemen with Challenge-enrolled horses.
- AQHA may match up to \$7,500. The money distributed by AQHA will be determined by a vote from the AQHA Racing Council.
- An amount equal to 7% the gross purse (including both track and AQHA sources) will be reserved by the Racing Department of AQHA to be used for enrollment awards at the end of 2016. The 7% is split among the enrollers of the top five finishers of the Bonus race; see AQHA Racing Challenge Condition and Rule Book for more information.
- To offset the 7% that is reserved for enrollment awards, we encourage you to collect nominating and/or entry fees to maintain the advertised purse total.
